66th CCUSBC Open Championship RULES

- 1. Three games will be bowled in each event. Each event will have two divisions. Bowlers can be men or women. A complete entry form just be submitted for each team. Bowlers may enter the team event more than once by changing two team members. Bowlers may enter the doubles event more than once by changing one team member. A bowler may enter singles 3 times, but cash only once. All Events consists of the total for the first series bowled in Team, Doubles and Singles.
- 2. Optional Events: TEAM scratch, DOUBLES scratch, SINGLES scratch and ALL EVENTS, both scratch and handicap, are optional events. When a bowler competes more than once, his/her first series in each event will count for the ALL EVENTS score.
- 3. All bowlers shall check in 30 minutes prior to their squad time. A bowler arriving late will be permitted to bowl with their score counting in the frame they start in. No make-up for missed frames. (USBC Rule 322a applies)
- 4. Entry fees are \$25 per bowler per event. Optional events are \$10 per bowler per event. Entry fee allocation is: Lineage \$11, Expenses \$3, Prize Fund \$11. The prize fund will be returned 100% on a 1:4 ratio. Optional event entry fee allocation is: Prize Fund \$9, Expense \$1.
- 5. Bowlers will use the highest USBC average from the 2013-14 winter season based on 21 games or more. USBC Rule 319(a) will apply: _If a bowler's January 1, 2015 average for 21 games or more is 10 pins or more higher than the prior season's average, the january 1, 2015 average must be used.

If no 2013-14 average, use highest current league average of 21 or more games at time of entry.

All others must bowl scratch (230). An average verification is required for a non-CCUSBC average.

It shall be each bowler's responsibility to verify the accuracy of his/her average. Failure to use the proper average or make a correction subsequent to completion of the first game of the series may have the bowler's score disqualified if the submitted average is less than the actual average.

The average of a bowler may be re-rated upward per USBC Rule 319d,e. If due to adjustment the entrant chooses not to bowl the entry fee will be refunded.

6. Handicap will be 90% of the difference between each bowlers average and 230 for Singles. Team will be the difference of team average and 1150. Doubles will be the difference of team average and 460.

- 7. All bowlers must be current members of the Clark County USBC (CCUSBC). If a bowler has purchased a membership in another association then he/she must purchase the appropriate local membership.
- 8. No more than two professional bowlers will be allowed to bowl on a five person team unless they are regular league members of the team and have bowled two-thirds of the league schedule as of the date of their tournament squad. One professional bowler is permitted on a doubles team. A professional bowler is defined as a bowler who holds a membership in a professional bowlers association.
- 9. Submit entry to CCUSBC at 2101 E Evergreen Blvd, #103, Vancouver, WA 98661 or by leaving at your bowling center. Entry fee must accompany entry form. No entry fee will be returned after entry has been confirmed. Exceptions will be at the discretion of the tournament director. Phone or email reservations are accepted (Information on front of entry). Send entry and fees as soon as possible. If entry has not been paid by the time tournament play begins, that spot can be given to another team or bowler.
- 10. All returned checks, for any reason, will be charged a fee of \$20 plus the amount of the check.
- 11. The first place winners in each handicap event will be awarded a Championship Award at the annual awards ceremony. One award per person per year.
- 12. USBC rules apply except otherwise stated in these rules.
